## Merry Christmas from Asylum Justice!

### Work Review for 2015:

Sadly, at the beginning of 2013, having operated for 8 years and having assisted over 3,000 clients, Asylum Justice was forced to suspend operations. Thanks to crucial funding from the Tudor Trust Asylum Justice were able to recommence operations and continue to provide free legal services to asylum seekers and refugees in Wales.

The Board of Trustees appointed Ruth Brown as Legal Director of Asylum Justice. Ruth joined in October 2014 and remains the only paid member of staff. Ruth has done and continues to do a fantastic job particularly when considering the extremely high demand for our services. Since reopening in January 2015 Ruth and our wonderful team of volunteers have assisted 277 asylum seekers and refugees both at our Monday night free legal advice drop-in at City United Reformed Church and at our office in Portland House. (113-116, Bute Street, CF10 5EQ)

We receive regular referrals from Migrant Help, Social Services, local Solicitors, Churches and Community Organisations, other NGOs/Charities, and the Women's refuge. We, in turn, regularly refer clients to local Solicitors, Asylum Support Organisations, other NGOs/Charities, Social Services, Experts, Medical Experts, and to First Responders. We offer one-off advice as well as full representation. We assist clients at the initial stage of their asylum and/or human rights claim but most of our work is focused on representing clients on appeal before the First-Tier and Upper Tier of the Tribunal. We assist a number of clients to challenge decisions made by Legal Aid lawyers to withdraw/refuse representation under Legal Aid. We also help a number of clients with fresh claims and with applications for refugee family reunion. (Read our Case Studies opposite)

## Case Studies: Family Reunion

A Syrian man from Dara'a Province fled to the UK after being detained and tortured on suspicion of supporting anti-government rebels. Although he was eventually granted asylum, his wife and four children were stuck in the middle of a war zone and he was completely beside himself when he realised he couldn't get legal aid for applying for family reunion. AJ did family reunion applications for his family members and they were recently all granted family reunion visas to come to the UK to join him here. They still haven't arrived, as they don't yet have the money to pay for 5 flights, but they are expected soon.

A Syrian Kurd who was detained for more than 4 months on his arrival in the UK on an apparent whim, the UK government wouldn't accept he was Syrian. He was detained in HMP Wormwood Scrubs for most of that time, and eventually the Home Office backed down, accepted his nationality and granted him asylum. By this time, he had become severely depressed, and continues to suffer from depression. His wife and four children had managed to escape from Syria to Turkey by this time, but were living in complete squalor there. AJ did family reunion applications for his family and we are currently awaiting the visa decisions in this case.

**Lesson learnt – it is a travesty that Syrian clients have no other means of help in seeking family reunion. AJ feels it has a moral duty to ensure that we do all in power to support these clients.**
